Qualifications and minimum eligibility conditions

- i. A Master's Degree with 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in a concerned/relevant/ allied subject from an Indian University, or an equivalent degree from an Accredited Foreign University.
AND
- ii. Ph.D. Degree has been awarded in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil/PhD Degree) Regulations, 2009 or 2016 and their amendments from time to time.
AND
- iii.
 - a. For Posts in Sl. No.2–Graduation in Law and One year teaching in IPR/One year research experience in IPR are additional compulsory requirements.
 - b. For Posts in Sl. No.3 –One year teaching in IPR/One year research experience in IPR is an additional compulsory requirement.
 - c. For Post in Sl. No.5 – One year teaching in IPR/One year research experience in IPR/ is a Registered Patent Agent is an additional compulsory requirement.

Note: Clarification regarding PhD

Provided, the candidates registered for the PhD programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinance/Bye-laws/Regulations of the Institutions awarding the Degree and such PhD. Candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfilment of the following conditions:-

- The PhD Degree of the candidate has been awarded in a regular mode;
- The PhD thesis has been evaluated by at least two external examiners;
- An Open PhD Viva Voce of the candidate has been conducted;
- The candidate has published two research papers from his/her PhD work, out of which at least one is in a referred journal;
- The candidate has presented at least two papers based on his/her PhD work in Conference/Seminars sponsored/funded/supported by the UGC/ICSSR/SCIR or any similar agency.

The fulfilment of these conditions is to be certified by the Registrar or the Dean (Academic Affairs) of the University concerned.

OR

The PhD Degree has been obtained from a Foreign University/Institution with a ranking among top 500 in the World University Ranking (at any time) by any one of the following: (i) Quacquarelli Symonds (QS) (ii) the Times Higher Education (THE) or (iii) the Academic ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai).

Starting pay

- Rs.57,700/-(equivalent of academic level 10 of UGC Pay Matrix with annual increment).

Additional Conditions

- The decision of the Selection Committee regarding shall be final.
- The Assistant Professor on tenure track contract basis appointment is for a maximum period of 5 years. The initial period of engagement is for one year which may be extended up to 5 years based on performance. Reservation Rules are applicable for the appointments to the above posts and are indicated in the notification against each post.
- Weightage will be given only for Teaching / Research experience related to the field of IPR for which proof should be produced.

- Applications to the above posts have to be submitted in the prescribed application form available in the website: www.cusat.ac.in
- Separate application with prescribed fee should be submitted for each post having separate serial number to "The Director, Inter University Centre for IPR Studies, Cochin University of Science and Technology, Cochin University P O, Kochi-22".
- The signed hard copy of the application with copies of documents to prove age, qualification (Mark list and Degree Certificate) / Specialisation, proof that the journals are approved by UGC/peer reviewed, Experience Certificate, Award, Proof for CGPA to percentage conversion and proof for all other additional qualification like UGC, NET, etc. and reservations, if any, should reach the Director, IUCIPRS, CUSAT, Kochi-22 with required fee **on or before 10.06.2026**.
- Late and defective applications will be summarily rejected.
